PRECEPTS (continued)

Lord, what must I do? Throughout history the Church has answered this question by Christ's command: "Go, teach all nations..." So the Church has given the Christian Principles to the pastoral requirements of each era. The Precepts of the Church are among those guiding principles.

The Church imposes on its members the duty of Observing the days of fasting and abstinence. She thus teaches us how to Watch for the Father's will by helping us exercise mastery over our appetites. Fasting and abstinence strengthen this habit of watchfulness. What Must I Do?

Friday's and certain vigils are days of abstaining from meat and reduced food as indicated by the Traditional Catholic Calendars. The laws of **fast** apply to persons between the ages of twenty-one and fifty-nine. On a fast day one may eat one full meal and two light meatless meals, which together would not equal the main meal. Meat may be taken at the principal meal, except on days of complete abstinence. Liquids such as water, milk, and fruit juices may be taken between meals. The laws of **abstinence** apply to everyone seven years of age and over. On a day of complete abstinence no meat, meat gravy or soup made from meat may be taken. On a day of partial abstinence meat may be taken once. There are *days of Fast*: All the days of Lent until Holy Saturday, Ember Days, the Vigils of Pentecost, the Immaculate Conception, Christmas, and All Saints. Days of *Complete Abstinence* include every Friday of the year, Ash Wednesday, Holy Saturday (until noon), the Vigils of All Saints, the Immaculate Conception, and Christmas. Traditional *Days of Partial Abstinence* include Ember Wednesdays and Saturdays and the Vigil of Pentecost. Local Custom in the USA- In many places in the United States before Vatican II, it was customary to dispense from the fast on St. Patrick's Day (March 17) and from abstinence on the Friday following Thanksgiving.
